- Homeowners with guests who will not be using any of the Recreational Facilities (pool, clubhouse, library, exercise room, pool room) will not need recreational tags, but the guests must still register in the office if staying three (3) days or longer.
- Guests who will be using the Recreational Facilities of Snug Harbor must register with the office and receive an assigned guest tag. A deposit of \$5.00 is required for EACH TAG. The deposit will be refunded if the tags are turned into the office one week after guest departure. If the tag(s) is/are not returned within this period, deposits WILL NOT be refundable.

- LONG TERM GUESTS: GUESTS STAYING LONGER THAN 30 DAYS WILL BE ISSUED RED RECREATIONAL TAG(S).
